INFORMATION ABOUT REACH & ROHS 3 registration substances (SVHC)

Trade Name:

- **FILAFLEX SEBS**

The products mentioned above supplied by RECREUS do not contain any SVHC according to the Candidate List of Substances of Very High Concern for Authorisation last updated 16. July 2019 as intentionally added ingredients. They are also compliant with EC Regulation 1907/2006 (REACH) as all substances the product are composed of,

- had been manufactured/imported under a valid pre-registration until May 31, 2018 and/or
- have been registered by RECREUS and/or its suppliers and/or
- are excluded from the Regulation (e.g. natural occurring substances), and/or are exempted from registration (e.g. polymers),

From our point of view possible reasons could be the following:

- The substance registration was filed in time, but ECHA did not send out a registration number and/or
- The product registration was submitted in time, but the required studies were not finalized yet.
- Therefore, a so-called DCG (Directors Contact Group)-exemption was used.

Based on the information available to us from our raw material suppliers, and our knowledge of the products' compositions, we confirm that the FILAFLEX SEBS products - listed above - do not contain any SVHC according to Candidate List of 'Substances of Very High Concern' for Authorization (last updated on 10. June 2022) above the threshold limit of 0,1% mentioned in REACH Regulation 1907/2006, § 33 insofar as these compounds are not intentionally added and are not part of the chemical composition of the used ingredients.



Directive 2011/65/EU (formerly 2002/95/EC, amended by 2015/863) on the restriction of the use of certain hazardous substances in electrical and electronic equipment

In RoHS Annex II restricted substances (Lead, Mercury, Cadmium, Hexavalent Chromium, Polybrominated biphenyls and Polybrominated diphenyl ethers (PBDE)) and maximum concentration values tolerated by weight in homogeneous materials are reported.

Delegate Directive 2015/863/EU, during the periodic revision of the Annex II, has introduced further restrictions adding the following substances:

- Bis(2-ethylhexyl) phthalate (DEHP)
- Butyl benzyl phthalate (BBP)
- Dibutyl phthalate (DBP)
- Diisobutyl phthalate (DIBP).

These further restrictions have fully entered into force on 22nd July 2019.
